Candidates must enroll no later than 15th November 2024

Applicants who do not complete the enrollment by the deadline indicated above lose the right to admission.

In order to enroll, the admitted candidates must follow these steps within the due date:

1. log in the segreteria on line and fill in the on line enrolment form

(from the right drop down menu, select home>enrollment>enrollment to restricted access courses);

2. pay the first installment of the tuition fees, using the pre-filled PagoPA form, that is printable at the end of the online enrolment procedure;

If the payment is to be made by third parties (e.g. companies, entities, etc.) other than the candidate,

they can request the issuance of a debit note by sending an e-mail to carriere.academy@unimib.it specifying their company name and Vat number.

Only and exclusively payments from foreign current accounts can be made by bank transfer, using the bank account indicated in the call (art.4)

In all cases of payment other than PagoPA, a receipt must be sent to the following email address carriere.academy@unimib.it.

Non EU students must send copy of the entry visa or the residence permit in Italy to carriere.academy@unimib.it
